

gINT SOFTWARE END-USER LICENSE AGREEMENT (“EULA”)

IMPORTANT—READ CAREFULLY: This End User License Agreement (“EULA” or “Agreement”) is a legal agreement between You (an individual or a single entity) (“You[r]” or “Licensee”) and gINT Software, Inc., whose address is 7710 Bell Road, Windsor, California 95492 (“gINT Software”) pertaining to the gINT® Professional™ software, gINT® Logs Plus™ software, gINT® Logs™ software, gINT® for ArcGIS™ software, each add-on module, update or other gINT Software-provided enhancement thereto (regardless whether You paid gINT Software therefor), any accompanying documentation that may be provided with such software, and any service, including, without limitation, any and all technical support, and any and all custom programming, provided through or in connection with such software (singularly and collectively, the “Software”), You are about to install, copy, download, access or otherwise use. gINT Software licenses the Software to You only upon the express condition that You accept all of this Agreement’s terms and conditions. You therefore should carefully read this Agreement before downloading, using, accessing, or installing the Software. By downloading, installing, copying, accessing or otherwise using the Software, You accept each provision of this Agreement and understand that this Agreement will be legally binding on You (including, in the case of an entity, the entity and each user of the Software in connection with such entity). If You do not agree to any provision of this Agreement, then gINT Software is unwilling to license the Software to You and You must not download, install, access, use, or copy the Software and You may return the Software to the authorized reseller or, if applicable, notify the authorized application service provider from whom You bought it for a full refund within ninety (90) days of purchase (the “Refund Period”). After the Refund Period, any and all license fees paid to gINT Software shall be non-refundable.

***Trial Versions.** If the Software version you download, install, copy, access, or otherwise use is a trial version of the Software (“Trial Version”), the total amount of time such Trial Version may be operated shall not cumulatively exceed eight (8) hours, absent gINT Software’s express consent. In addition to being subject to each of the other conditions of this Agreement, the Trial Version Software may not be installed, used, operated, accessed or otherwise used electronically through a network of any description, whether using technologies now known or later devised, including, without limitation, in connection with Windows® Terminal Services or Xvand’s IsUtility®, any virtual private network, the Internet, or any computer network.*

1. Any installation, copying, distribution, access or use of the Software that exceed(s) any provision of this Agreement constitutes copyright infringement and may be punishable in a federal criminal action by fines and imprisonment. In addition, federal civil remedies for copyright infringement allow for the recovery of actual

damages based on the number of copies produced or, if gINT Software so elects, statutory damages of up to U.S. \$150,000 per work for willful copyright infringement. Please promptly report any copyright violations to gINT Software: by email to piracy@gintsoftware.com or by phone at +1 707 838 1271.

2. **License Extensions.** If Your intended Software usage exceeds the parameters set forth in this Agreement, please contact gINT Software to discuss a license extension.
3. **Term.** You may install and use the Software on Your computer(s) for so long as You abide by each provision of this Agreement.
4. **License Grant.** The Software is protected by copyright laws and international copyright treaties, as well as other intellectual property laws and treaties. Subject to each provision of this Agreement, the Software is licensed, not sold, to You as follows: gINT Software hereby grants to You, solely during the Term, a limited, nonexclusive, nontransferable license, with no right to grant any sublicense, (the “**License**”) to install and use machine-readable object code versions of the Software strictly pursuant to the type of license issued to You by gINT Software as described below in the subsections of this Section 4.
 - a. **Location-Based Licensing.** If this license is a gINT “Location-Based” License (typically a license number beginning with the letters “CG” or “IG” as indicated in the letter accompanying your purchase or upgrade), then this subsection 4(a) and its subsections applies to You. Use of each gINT Location-Based License is RESTRICTED TO ONE (1) LOCATION (STREET ADDRESS) as registered with gINT Software at time of purchase, and for temporary field offices of that location (together, “**The Location**”). If the address of The Location using the software changes, You must notify gINT Software in writing. **This Location-Based License may only be used at The Location.** A “temporary field office” is defined as a short-term location at which company business is performed, typically in existence for less than one year, which does not at any time have its address and/or telephone numbers listed publicly in company advertisements, including location listings on company web site pages and telephone directories. Satellite offices are not considered “field offices” for Location-Based licensing purposes and are not eligible to use licenses of the Software issued to The Location. Use of this license at any location other than The Location violates this Agreement. **THIS LICENSE MUST BE USED ONLY AT THE LOCATION.** If You wish to use the Software at any office location other than The Location, You must purchase separate Software licenses. To do so, please contact gINT Software at sales@gintsoftware.com. The software may be installed on as many computers as desired at The Location, but the total number of licenses operated simultaneously at your location may not exceed the number of gINT licenses owned by your company and designated for The Location.
 - i. **Single-user Licenses.** If the type of license You have purchased is a location-based “single-user license” or “standalone license” (as indicated

in the letter accompanying your purchase or upgrade), each purchased license may be operated on only one (1) computer at a time at this location via a license activation code, or by hardware key purchased from or included by gINT Software for The Location. Single-user licenses activated with software key codes may be moved from one computer to another at The Location using methods outlined in the licensing documentation, including the gINT Software Installation and Quick Start Guide. SINGLE-USER LICENSES MAY NOT BE INSTALLED, USED, OPERATED, OR ACCESSED ELECTRONICALLY THROUGH A NETWORK OF ANY DESCRIPTION, WHETHER USING TECHNOLOGIES NOW KNOWN OR LATER DEvised, INCLUDING WITHOUT LIMITATION IN CONNECTION WITH WINDOWS[®] TERMINAL SERVICES OR XVAND'S ISUTILITY[®], ANY VIRTUAL PRIVATE NETWORK, THE INTERNET, OR ANY COMPUTER NETWORK. Any installation, copying, distribution, or use of the Software prohibited by this Agreement will result in automatic termination of this Agreement and may constitute copyright infringement (see Section 1 above).

- ii. ***Local-Area Network (LAN) Licenses.*** If the type of license You have purchased is a location-based Local Area Network (LAN) license, You may install, but not operate, the Software on as many computers as desired within The Location, including employee laptops that may operate offsite in a temporary field office location (see definition in 4.a. above) or home office. However, the total number of licenses operated simultaneously over the LAN, including any that have been checked out by the license manager, may not exceed the number of gINT LAN licenses owned by You for this location. The number of authorized licenses for the Software is managed by a license manager file installed on the LAN and is activated by a combination of a software activation code and a hardware key for the LAN server. LAN LICENSES MAY NOT BE USED OVER A WIDE-AREA NETWORK (WAN) THAT IS ACCESSIBLE TO USERS OUTSIDE THE OFFICE LOCATION SPECIFIED AT PURCHASE TO GINT SOFTWARE. LAN LICENSES MAY BE USED OVER WINDOWS TERMINAL SERVICES, VPNs OR SIMILAR COMPUTER NETWORKS *ONLY IF* ACCESS TO THESE NETWORKS IS RESTRICTED TO USERS AT THE DESIGNATED LOCATION. Any installation, copying, distribution, or use of the Software prohibited by this Agreement will result in automatic termination of this Agreement and may constitute copyright infringement (see Section 1 above). To upgrade from a location-based LAN license to a non-location-based WAN license that may be legally shared across multiple locations, or to increase the quantity of licenses available at Your location, please contact gINT Software at sales@gintsoftware.com.

- b. **WAN Licensing.** If this license is a gINT Wide Area Network (“WAN”) License (typically a license number beginning with the letters “WG” or “ZWG” as indicated in the letter accompanying your purchase or upgrade), then this subsection 4(b) applies to You. Your gINT WAN License(s) may be accessed over Your WAN by any individual within Your Business Entity. For the purpose of this subsection, “**Business Entity**” means You or Your respective corporation, partnership, LLC, LLP, foundation, estate, trust or other organization as declared to gINT Software as the licensee at the time of Your license purchase. Your independent contractors may use your gINT license(s) but only during the period of their employment with you. The Software may be installed, but not operated, on any number of computers owned and controlled by the Business Entity. However, the total number of licenses operated simultaneously over the WAN may not exceed the number of gINT WAN licenses owned by Your Business Entity and designated for this location. Actual operation of the Software is managed by a license manager file installed on the WAN and activated by a combination of a software activation code and a hardware key for the WAN server. WAN LICENSES MAY NOT BE USED BY INDIVIDUALS OUTSIDE THE BUSINESS ENTITY AND MAY NOT BE OFFERED FOR PUBLIC USE OVER THE INTERNET OR OTHER COMPUTER NETWORK THAT ALLOW ACCESS BY USERS WHO ARE NOT PART OF THE BUSINESS ENTITY. Such usage is prohibited by this Agreement and will result in automatic termination of this Agreement and may constitute copyright infringement (see Section 1 above). EACH WAN LICENSE MAY NOT BE OFFERED OR PROVIDED FOR USE, OPERATION, OR ACCESS ELECTRONICALLY THROUGH A NETWORK OF ANY DESCRIPTION, WHETHER USING TECHNOLOGIES NOW KNOWN OR LATER DEvised, INCLUDING WITHOUT LIMITATION IN CONNECTION WITH WINDOWS[®] TERMINAL SERVICES OR XVAND’S isUTILITY[®], ANY VIRTUAL PRIVATE NETWORK, THE INTERNET, OR ANY COMPUTER NETWORK, TO ANY USER NOT EMPLOYED BY THE BUSINESS ENTITY. Any installation, copying, distribution, or use of the Software prohibited by this Agreement will result in automatic termination of this Agreement and may constitute copyright infringement (see Section 1 above).
- c. **Application Service Provider (ASP) User Licenses.** If You have paid for use of this Software through an Application Service Provider (“ASP”), including, without limitation, Cetrus, Inc., the type of license You have purchased is an ASP User License. As noted above, YOU MAY NOT USE THIS SOFTWARE WITHOUT CONSENTING TO THIS AGREEMENT IN ITS ENTIRETY. You may use or access the Software on each computer for which you have lawfully acquired from the ASP a valid, current on-demand license for which a positive prepaid account balance is maintained for the Software or for which a prepaid fixed-term license has been established with the ASP. This license grant license expires and is no longer valid at the end of the pre-paid license term, or when the

monetary balance in the pre-paid account is no longer positive. Access to and use of the Software is further limited by each provision of this Agreement and of the ASP's User License Agreement. If You breach any provision of this Agreement or the ASP's User License Agreement, Your license to use the Software is automatically terminated. Furthermore, any installation, copying, distribution, or use of the Software may constitute copyright infringement, as defined in Section 1, above.

- d. **Archival copies.** Provided that You label each copy authorized by this subsection 4(d) with each Software proprietary notice, You may make up to five (5) copies of the Software media solely: (i) for archival (backup) purposes; and (ii) to re-install the Software strictly pursuant to each provision of this Agreement. This section does not apply to You if you have accessed the Software through an ASP.
5. **Additional License Restrictions.** gINT Software expressly reserves all rights not specifically granted to You pursuant to this Agreement. This License terminates immediately upon any breach by You of any provision of this Agreement. The License granted shall not extend to any third party. Except as specifically permitted pursuant to this Agreement, Licensee shall not: (i) allow any third party to use or access the Software for any direct or indirect fee; (ii) copy (except as permitted by applicable law or as provided in this Agreement), sell, modify, translate, transfer, reverse engineer, decompile or disassemble the Software; (iii) remove any Software proprietary notice, label or mark, whether in machine language or human readable form; (iv) transmit or distribute the Software to any person or entity not expressly authorized pursuant to this agreement; (v) create any derivative work that is based on or incorporates the Software; (vi) sublicense, assign, delegate or otherwise transfer the License or any right or obligation related to it for any reason without gINT Software's prior written consent (any attempt to sublicense, assign, delegate or transfer this license, by contract, statute, corporate merger of any sort, regulation or court order without gINT Software's prior written consent shall be void); (vii) export the Software outside of the country in which it was purchased or permitted as declared to gINT Software upon purchase, without gINT Software's express prior written consent; or (viii) install or operate the Software on any computer or server not expressly permitted pursuant to this Agreement, whether through physical transfer of a copy, electronic access through a network of any description, or by any other means now known or hereinafter devised. Upon termination of either the License or this Agreement for any reason, the License shall terminate and any user accessing the Software shall immediately cease to use or have access and support for it. UNAUTHORIZED COPYING OF THE SOFTWARE OR FAILURE TO COMPLY WITH ANY PROVISION SET FORTH IN THIS AGREEMENT SHALL RESULT IN THE LICENSE'S AUTOMATIC TERMINATION.
6. **Upgrades and Enhancements.** If gINT Software or its authorized agent provides You additional software that upgrades, updates, supplements or otherwise extends the Software, that additional software shall be subject to this Agreement unless gINT Software otherwise agrees in writing. If the Software is an upgrade ("**New Version**") to software previously

licensed to You (“**Previous Version**”), You cannot operate both the new version and the previous version unless specifically authorized in writing by gINT Software. If you are simultaneously running both a New Version and a Previous Version, the total number of licenses that you may operate simultaneously shall not exceed the total number of software licenses issued to you by gINT Software.

7. **Compliance.** You agree that gINT Software may at any time, upon reasonable notice, audit Your use of the Software for compliance with this Agreement. If such audit reveals any use of the Software by You other than in full compliance with this Agreement, You shall reimburse gINT Software for all reasonable expenses related to such audit in addition to any other liabilities You may incur as a result of such non-compliance.
8. **Title and Copyright.** It is hereby understood and agreed that as between gINT Software and You, gINT Software owns all rights, title and interest, including without limitation all copyrights and other legally recognized proprietary rights, in and to the Software, as recorded on the media on which the Software is furnished to You and any subsequent copy, whether using any technology now known or hereafter devised. Except as expressly provided herein, You do not acquire any rights to the Software through this Agreement. Licensee agrees that any changes or additions to the program and documentation are the property of the Licensor and that Licensee has no claim to any future royalties or other compensation.
9. **No Warranties.** The Software is furnished “as is” and with all faults. gINT Software, its owners, employees, contractors, investors, resellers, distributors, ASPs, and sublicensees (singularly and collectively, the “**Disclaiming Parties**”) make, and You receive, no warranty of any kind, whether express, implied, statutory, or in any communication with You. To the maximum extent permitted by applicable law, the Disclaiming Parties disclaim any and all other warranties and conditions, express or implied, including, but not limited to, implied warranties or conditions of merchantability, fitness for a particular purpose, title, non-infringement, or any warranty that operation of the Software will be uninterrupted or error-free. Licensee expressly assumes all risk resulting from support services (whether performed in whole, in part, or not at all), or from any virus, downloaded material, harmful component, or through any Internet use resulting from or relating to Licensee’s use of the Software or any site or server through which the Software is available. Licensee shall be solely responsible for the accuracy and transmission of all data entered, any damage that results from or is associated with use of the Software. The Software is intended to be used by trained professionals only. It is not a substitute for professional judgment or independent testing. The Software has not been tested in all situations under which it may be used. The Disclaiming Parties shall not be liable in any manner whatsoever for the results obtained through use of the Software. Persons using the Software are responsible for the supervision, management and control of the Software. This responsibility includes, but is not limited to, the determination of appropriate uses for the Software and the selection of the Software and other programs to achieve intended

results. Persons using the Software are also responsible for establishing the adequacy of independent procedures for testing the reliability and accuracy of the Software's output.

10. **Limitation of Liability.** The limitation of liability is to the maximum extent permitted by applicable law. In no event shall the Disclaiming Parties be liable for any damages, whether arising in contract, tort or otherwise and including, without limit, any special, incidental, indirect, or consequential damages whatsoever (including, without limitation, damages for loss of business profits, business interruption, loss or corruption of business information or other data, cost of cover, or any other pecuniary loss) arising out of the use of or inability to use the Software or the failure to provide full or adequate support services, even if the Disclaiming Parties have been advised of the possibility of such damages. You acknowledge that the license fee amount reflects this allocation of risk. In any case, the entire liability of the Disclaiming Parties, under any provision of this Agreement shall be limited to the greater of the amount actually paid by You to gINT Software (or, if applicable to an ASP) in License fees during the year in which any claim is brought, for the Software or five U. S. dollars (\$5). Because some states do not allow the exclusion or limitation of liability, the above limitation may not apply to You.
11. **Governing Law/Jurisdiction.** This Agreement shall be exclusively governed by and construed under the laws of the State of California without reference to principles of conflicts of laws. All disputes hereunder shall be resolved exclusively in the appropriate state court in the City and County of San Francisco, California or federal court for the Northern District of California, U.S.A. You consent to exclusive jurisdiction in such venue and expressly waive any objection to same.
12. **Assignment.** You may not assign this Agreement without gINT Software's prior written consent.
13. **Export / Local Compliance / U.S. Government Matters.** Notwithstanding anything contained herein to the contrary and regardless of any disclosure made by Licensee to gINT Software of any ultimate destination of the Software, Licensee shall not export directly or indirectly the Software acquired from gINT Software, or any technical data derived therefrom, without first obtaining the written approval or required export license to do so from the United States Department of Commerce or any other agency of the U.S. government or of any foreign government having jurisdiction over such transaction, when required by any applicable statute, regulation or order. Licensee also shall comply with all state, federal, and local rules and regulations relating to Licensee's use of the Software, and Licensee shall indemnify gINT Software for any failure to so comply. The Software and User Documentation are "Commercial Items," as that term is defined at 48 C.F.R. §2.101, consisting of "Commercial Computer Software" and "Commercial Computer Software Documentation," as such terms are used in 48 C.F.R. §12.212 or 48 C.F.R. §227.7202, as applicable. Consistent with 48 C.F.R. §12.212 and 48 C.F.R. §§227.7202-1 through 227.7202-4, as applicable, the Software and User Documentation are being provided to U.S. Government end users (1) only as a Commercial Item, and (2) with only

those rights as are granted to all other end users pursuant to the terms and conditions of this Agreement. Manufacturer is gINT Software, Inc., 7710 Bell Road, Windsor, California 95492 USA.

14. **Indemnification.** If the Software is modified (including without limit any change to the Software's initialization file[s]), installed or used in violation of any Agreement prohibition or any warning, instructions, or recommendation by the Disclaiming Parties, You hereby agree to, and You therefore shall, defend and indemnify and hold the Disclaiming Parties harmless from and against all claims of any kind for any expense, injury, loss, or damage arising out of, connected with, or resulting therefrom.
15. **Equitable Relief.** You acknowledge that, at the time this Agreement is entered, it would be impossible or inadequate to measure and calculate all of the damages of gINT Software, its resellers, distributors, and sublicensees, for the breach of certain provisions of this Agreement and that it would require a court of competent jurisdiction to ascertain such damages. Accordingly, if You breach or threaten to breach any of Your obligations, other than payment when due, gINT Software, its resellers, distributors, and sublicensees shall be entitled, without showing or proving any actual damage sustained, to a stipulated temporary restraining order, and shall thereafter be entitled to apply for a preliminary injunction, permanent injunction, and/or order compelling specific performance, to prevent the breach of Your obligations under this Agreement. Nothing in this Agreement shall be interpreted as prohibiting gINT Software, its resellers, distributors, or sublicensees from pursuing or obtaining any other remedies as otherwise available to it for such actual or threatened breach, including recovery of damages.
16. **General.** This Agreement sets forth the entire agreement and understanding of the parties relating to the specific subject matter herein and merges and supersedes all prior agreements, writings, commitments, discussions and understandings between them. No modification of or amendment to this Agreement, nor any waiver of any rights under this Agreement, shall be effective unless in authorized in writing by gINT Software. If any Agreement term is held by a court of competent jurisdiction to be invalid or unenforceable, then this Agreement, including all of the remaining terms, will remain in full force and effect as if such invalid or unenforceable term had never been included. This Agreement shall be construed within its fair meaning and no inference shall be drawn against the drafting party in interpreting this Agreement.

YOU HEREBY ACKNOWLEDGE THAT YOU HAVE READ THIS AGREEMENT, UNDERSTAND IT, HAVE THE AUTHORITY TO ENTER INTO THIS AGREEMENT AND CONTRACTUALLY BIND LICENSEE. BY CLICKING ON THE "I AGREE" BUTTON BELOW, YOU ACCEPT EACH PROVISION OF THIS AGREEMENT AND UNDERSTAND THAT YOU ARE ENTERING INTO A LEGALLY BINDING AGREEMENT.
